# ABOUT THE SPEAKERS



## **Luke Bernstein, President and CEO, PA Chamber of Business and Industry**

A seasoned financial, government, and public policy professional, Luke came to the organization in 2022 with more than 20 years of experience in the public and private sectors.

Before leading the PA Chamber, Luke was most recently executive vice president, chief operations and technology officer at Orrstown Financial Services. He had served as Orrstown's corporate spokesperson since 2017.

He was previously senior vice president of external affairs at the Pennsylvania Bankers Association from 2015 to 2017 and deputy chief of staff for former Pennsylvania Gov. Tom Corbett from 2011 to 2015.

Luke also completed the Duke Leadership Program at Duke University's Fuqua School of Business. He is a very active member of his community, serving on numerous boards and as a youth sports coach.



## **Toby Rice, President & CEO, EQT**

Toby Z. Rice is President and Chief Executive Officer of EQT, the largest natural gas producer in the United States. As an influencer and champion for the energy industry, Mr. Rice has been a strong proponent of unleashing American energy to provide energy security and independence here in the United States and to our allies worldwide, while also achieving our ambitious climate goals.

Mr. Rice was named President and Chief Executive Officer of EQT in July 2019. Since then, EQT has reduced greenhouse gas (GHG) emissions by 35 percent and achieved one of the lowest methane intensities of any natural gas producer globally. In addition, EQT has set the industry's most aggressive net-zero goal, pledging to achieve net-zero Scope 1 and 2 GHG emissions in its Production segment operations by or before 2025. Mr. Rice has also led EQT to achieve 50 percent female representation on its Board of Directors.

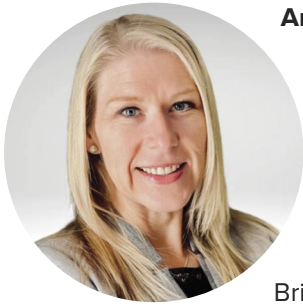
Since May 2018, Mr. Rice has also served as a Partner at Rice Investment Group, a multi-strategy fund investing in all verticals of the oil and gas sector, including the largest renewable natural gas company.

Prior to being appointed EQT CEO, Mr. Rice served as President, Chief Operating Officer, and member of the Board of Directors of Rice Energy. He also held various positions with Rice Energy, its affiliates, and predecessor entities.

He has spoken at a variety of energy conferences and seminars, including CERA Week, Financial Times: Energy Source Live, Shale Insight, and DUG East. He has also served as an energy industry analyst appearing on CNN, CNBC, Bloomberg TV, Fox Business, and Fox News. He graduated from Rollins College in 2004 with a Bachelor of Science degree in Chemistry.

Mr. Rice serves on the Bipartisan Policy Center's American Energy Innovation Council board. He is also an American Exploration and Production Council's Executive Committee member.

Additionally, Mr. Rice serves on the board of the EQT Foundation, which is committed to supporting the education and training of children and adults, the development of diverse, livable communities, and the preservation of our natural environments.



**Amy Brinton, Director, Government Affairs, PA Chamber of Business and Industry**

An experienced and widely respected government affairs and policy leader, Brinton will oversee the PA Chamber's advocacy in several key policy and regulatory areas, including energy and environmental issues.

**Stephen Bennett, Sr. Manager, Regulatory and Legislative Affairs, PJM Interconnection**

Mr. Bennett is the PJM liaison for Illinois, Ohio and Pennsylvania. In this role, he interacts with state utility commissions, executive agencies and legislators on energy policy in the areas of RTO grid reliability, transmission planning, operations and wholesale markets. Prior to joining PJM, Mr. Bennett was the Managing Director at Energy Advocacy, LLC, a boutique consultancy focused on regulatory policy in the retail and wholesale energy markets. Mr. Bennett also held management roles in government affairs for both PPL EnergyPlus and Exelon. Mr. Bennett has a Bachelor of Science in Engineering from the University of Maryland, College Park.

PJM Interconnection, founded in 1927, ensures the reliability of the high-voltage electric power system serving 65 million people in all or parts of Delaware, Illinois, Indiana, Kentucky, Maryland, Michigan, New Jersey, North Carolina, Ohio, Pennsylvania, Tennessee, Virginia, West Virginia and the District of Columbia. PJM coordinates and directs the operation of the region's transmission grid, which includes over 82,000 miles of transmission lines; administers a competitive wholesale electricity market; and plans regional transmission expansion improvements to maintain grid reliability and relieve congestion. PJM's regional grid and market operations produce annual savings of \$2.8 billion to \$3.1 billion. **Glen Thomas, President, GT Power Group**

Glen Thomas is the former chairman of the Pennsylvania Utility Commission (PUC), where he oversaw the restructuring of Pennsylvania's electricity, natural gas, and local telephone markets. Before his appointment to the PUC, Mr. Thomas served as deputy director of Governor Ridge's Policy Office, where he advised the governor on energy and environmental issues. In addition, Mr. Thomas was appointed by California Gov. Arnold Schwarzenegger to serve on the governor's transition team for energy related issues in 2003. Mr. Thomas is also a former partner at the law firm of Blank Rome. Mr. Thomas currently serves as President of the PJM Power Providers Group, a non-profit organization dedicated to properly designed and well-functioning markets in the PJM region.

Mr. Thomas has served as president of the Mid-Atlantic Association of Regulatory Utilities Commissioners; chairman of the National Association of Regulatory Utility Commissioners Washington Action Committee; and a member of the U.S. Department of Energy's Electricity Advisory Board, the National Regulatory Research Institute's Board of Directors, the Keystone Center Energy Board, the Organization of MISO States Board of Directors, and the National Association of Regulatory Utility Commissioners Committee on International Relations, Telecommunications and Critical Infrastructure.

Mr. Thomas received his J.D. from Dickinson School of Law and his Bachelor of Arts in philosophy/religion and political science from Colgate University. He attended the Governors Center of the Terry Sanford Institute of Public Policy at Duke University, the John F. Kennedy School of Government, and the Program for Senior Executives in State and Local Government at Harvard University. He was one of the 60 civilians chosen by the Secretary of Defense to participate in the U.S. Department of Defense Joint Civilian Orientation Conference.

Mr. Thomas has been honored by the Philadelphia Business Journal and the Central Pennsylvania Business Journal as recipient of the "40 Under 40" Award. He is also a member of the Wilson High School Academic Hall of Fame.



**Sen. Gene Yaw, PA-23, Chairman, Senate Environmental Resources & Energy Committee**

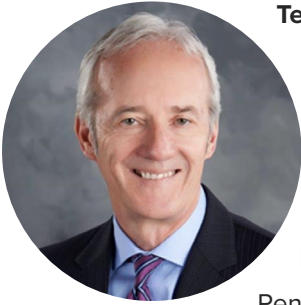
Prior to running for the Senate, Yaw served as Lycoming County solicitor for 17 years and was named County Solicitor of the Year in 2004. He has also served as general counsel to the Pennsylvania College of Technology for more than 20 years. In 2013, he was elected Chairman of the Pennsylvania College of Technology Board of Directors. Senator Yaw serves as Chairman of the Environmental Resources and Energy Committee.

He is also Vice Chairman of the Senate Judiciary Committee, and a member of the Agriculture & Rural Affairs, Banking & Insurance, Community, Economic & Recreational Development, Rules & Executive Nominations and the Majority Policy Committees.

Senator Yaw serves on a number of Boards and Commissions including as Chairman of the Center for Rural Pennsylvania, a member of the Chesapeake Bay Commission, a member of the Environmental Quality Board, a member of the Pennsylvania Aggregate Advisory Board, a member of the Pennsylvania Energy Development Authority and a member of the Joint Legislative Air and Water Pollution Control And Conservation Committee.

Senator Yaw is a member of the Lycoming Law Association and Pennsylvania Bar Association, Pennsylvania Association for Justice, and a former member of the Board of Directors of Susquehanna Legal Services. He serves as "Of Counsel" with the McCormick Law Firm in Williamsport, a prominent firm which has been in continuous existence for 150 years. A U.S. Army veteran, Yaw enlisted and went on to graduate from the United States Artillery and Missile Officer Candidate School in Fort Sill, Oklahoma. He served an overseas tour of duty as an artillery officer and was honorably discharged as a 1st Lieutenant. Senator Yaw has coached Little League Baseball, and coached and refereed for the American Youth Soccer Organization. He is a member of the National Rifle Association, Ducks Unlimited, the Nittany Lion Club, and the Williamsport-Lycoming Chamber of Commerce. He received the 2010 Distinguished Citizen of the Year Award from the Susquehanna Council, Boy Scouts of America, the 2011 Lycoming College Alumni of the Year Award, the 2011 CAPP Community Partner Award, the Central Pennsylvania State of Israel Bonds 2012 Israel Unity Award, the 2013 Pennsylvania Winery Association Industry Supporter Award, the 2014 Pennsylvania College of Technology Centennial Leadership Award, the 2015 Pennsylvania Office of Rural Health Legislator of the Year Award and the 2019 Pennsylvania Water Environment Association Public Official of the Year Award.





**Terry Fitzpatrick, President & CEO, Energy Association of PA**

Terrance J. Fitzpatrick is President and CEO of the Energy Association of Pennsylvania, which represents the interests of electric and natural gas utilities in the Commonwealth. From 1999 to 2007, he was a Commissioner of the Pennsylvania Public Utility Commission, serving as Chairman from 2003 to 2004. From 1995 to 1997, he served as Counsel to the Environmental Resources and Energy Committee in the Senate of Pennsylvania, and helped to draft Pennsylvania's electricity competition law. During his career, he has also served as an administrative law judge with the Pennsylvania Environmental Hearing Board and as legal counsel with the PUC, with the Insurance Department, with two private law firms, and with the Electric Power Generation Association. He has authored articles on administrative law and energy topics, and a white paper on improving infrastructure in Pennsylvania.



**Peter J. Keenan, Senior Director of Engineering – Technical Services, PA American Water**
